

IN HOUSE COUNSELING:

Elderly people often neglected, and do not really have a chance to say how they are feeling, or what has gone on for them during their lives. Counseling is the best way out of better understanding of the inmate's rehabilitation process. It gives them a chance to express fully, and it makes them a part of the house. Most of the time they come back from their loneliness and respond with others.

Aaghosh Trust has been providing its uncountable services with the great passion of humanity from 18 years. Aaghosh started its pronounced mission in 2003, it was the institution who prior to all helped special children/persons in getting their respectable place in the society, because it is the fact that special child does not get attention in the society which they deserve. Other than that, when special child born in any family, they face lots of issues and problems, majority of them are created by our society and lack of facilitation provided by our government sector. Aaghosh took this essential responsibility to have disable/handicapped persons got their deserved rights in the society at the time even when there were no significant institutions available for their education or either training.

Our goal was to create awareness in the societies that there should be special institutions for disabled persons like normal children's schools where they get all the necessary needs to be fulfilled. If you observed in now days, special children's schools and training centers are doubtless proof that Aaghosh has really helped handicapped persons in getting their legal rights in the society. Moreover, it has not only empathized with their needs but fulfilled them.

With corrective education and vocational training, Aaghosh has made these handicapped children capable to the level where they can stand on their own feet and now can earn by themselves. We have also arranged exhibitions in different hotels, seminars even in expo center to show people that if we provide the required attention and facility to these disabled persons, so they can perform better and can be able to earn by themselves instead of begging. The purpose behind this was to realize that handicapped persons are not useless. They can be a productive for our society if we fulfill their needs.

Aaghosh Home has been setup with the aim of providing shelter, hygienic food, medical assistance, and home like environment with peace of mind to those unassisted handicapped and senior women who do not have anyone to take care. Many of them are those old women old widow mothers who lost their son and the only bread earner in some incident. Women adduced in Aaghosh home faced very difficulties, hurdles, and mishaps in their lives, due to this most of them are mentally depressed and psychotic patient or mentally and physically handicapped. In Aaghosh Home, these women get relieve with their worries of surviving in this harsh world alone specially in their old age and find them a new life with all basic needs. care and extra attention.

SERVICES

Just like the rest of us, elderly people also want to enjoy good health and an independent life. As people grow older, remaining independent often depends on their health, well-being and social care service being effective enough to support them. Elderly people mostly required health and social care services but often these services are extremely limited comparing to their needs.

The core objective of the program is to make sure that all elderly people and their care takers are always treated with respect, dignity, and fairness. The Aaghosh Trust Old Age Home premises offers a decent infrastructure, including clean and comfortable beds and livings rooms, dormitories, and physical & social activities area impeccably appropriate to cater to the needs of elderly people. The design of the premises was conceived after visiting and assessing facilities and arrangements of several similar institutions to make it appropriate living space for the inmates.

HOUSING WITH CARE:

Aaghosh Home provides complete housing services during day and night. It is not the center for working people. It is a place for marginalized and abandon senior citizens and they have a liberty to enjoy as they desire

HEALTH CARE:

Older people have many degenerative diseases to deal with such as Arthritis, Rheumatism, Osteoporosis, High blood pressure, Heart failure, and Strokes. Along with all the physical pain and debilitating illness, they need daily medical checkup and medication which keep them save from the diseases. with any medical urgency.

PHYSIO THERAPY:

As the elderly people go in the life later stages their physical frailty increases and the body does not respond accordingly. To keep them robust they need daily gentle exercises and gym for fitness. Aaghosh Home has a fully equipped Physical therapy and rehabilitation unit to meet the needs of inmates.

STAY HEALTHY:

Knowing that good nutritious meal keeps elderly people always healthy. A proper diet reduces the risk of degenerative diseases, heart disease, stroke, high blood pressure, and control diabetes. A well dietary schedule is maintained with the consent of Dietitians and nutritionists to serve best nutritious meal to the elderly people.






CRUELTY OF THE SOCIETY WITH MRS. RAZIA.





Independent Auditor's Report to the Trustees

Opinion

We have audited the financial statements of **AAGHOSH TRUST**, which comprise the statement of financial position as at **June 30, 2022** and the income and expenditure account for the year then ended, and notes to the financial statements. Including a summary of Significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the statement of financial position as at June 30, 2022 and the income and expenditure account and reserves for the year ended June 30, 2022 in accordance with approved accounting and reporting standards as applicable in Pakistan.

Basis for Opinion

We conducted our audit in accordance with the International Standards on Auditing (ISAs) as applicable in Pakistan. We are independent of the trust in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants as adopted by the Institute of Chartered Accountants of Pakistan (the Code), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Managing Committee for the Financial Statements

The Managing Committee are responsible for the preparation and fair presentation of the financial statements in accordance with the approved accounting and reporting standards as applicable in Pakistan, and for such internal control as the trust determine is necessary to enable the preparation of financial statements that are free from material misstatement, Whether due to fraud or error.

In preparing the financial statements, Managing Committee are responsible for assessing the trust ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the trust or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the trust financial reporting process.
